



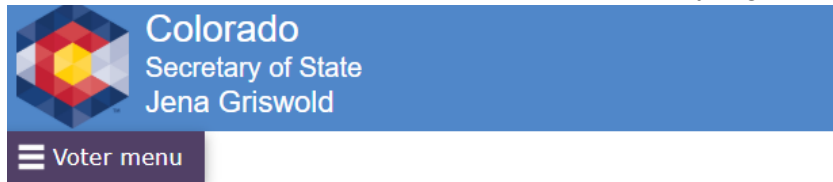
2020 General Election Information

The Eagle County Clerk and Recorder's Office would like to remind voters to check their voter registration information to ensure timely receipt of their November 3, 2020 General Election ballot. Voters should verify the following information:

- **Residential Address** - where you reside in Eagle County.
- **Mailing Address** - where you receive mail, if different from your residential address.
- **Ballot Mailing Address - optional field** - if you will be at a different mailing address when ballots for the General Election are mailed on October 9, 2020, please include a third address where you will receive your ballot. By law, ballots are not forwardable, so the proper mailing or ballot mailing address is critical for receipt of your General Election ballot.

If you will not be at your primary mailing address when ballots are mailed and need your ballot to be sent to an alternative address, fill out the optional field "Mail My Ballot To a Different Address." Please note, this is only for your ballot. All other election correspondence will be sent to your mailing address. Only select this option if your primary residence is in Eagle County but you will not be there to receive the ballot. Ballots may never be forwarded by the U.S. postal service.
