We have audited the financial statements of Eagle County Air Terminal Corporation (the "Corporation") as of and for the year ended December 31, 2015. Professional standards require that we provide you with the following information related to our audit.

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Corporation are described in note 2 to the audited 2015 financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during the year. We noted no transactions entered into by the Corporation during the year for which there is a lack of authoritative guidance or consensus. There are no significant transactions that have been recognized in the financial statements in a different period than when the transaction occurred.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimates affecting the financial statements were:

- Estimating the allowance for doubtful accounts (\$25,000 at December 31, 2015), based on management's experience with tenants and concessionaires, together with actual collections since year-end.
- Estimating useful lives of certain capital assets, in connection with the depreciation of those assets. Management's estimates are based on industry practice and experience with the underlying assets.

We evaluated the key factors and assumptions used to develop these estimates, and found them reasonable in relation to the financial statements taken as a whole.

Difficulties Encountered in Performing the Audit

We encountered no difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during an audit, other than those that are trivial, and communicate them to the appropriate level of management. Management has corrected all misstatements prior finalization of the 2015 audited financial statements.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

As is required in all audit engagements, we have requested certain representations from management that are included in the management representation letter.

In the course of our audit, we noted the following item that we present for your review and consideration.

Bad Debt Expense

During our fieldwork, we noted that there was an outstanding balance from one of the Corporation's concessionaires, TIGA Advertising, in the amount of \$25,000. According to the executed contract extension terms, this amount was payable for period beginning June 1, 2015 through August 31, 2015. To date, no amounts have been received. It is our understanding the County Attorney has contacted TIGA Advertising regarding this past due balance, but has been unsuccessful in collection attempts. As a result, the Corporation recognized an allowance for doubtful accounts and corresponding bad debt expense for this amount within its 2015 audited financial statements.
