**STANDING PUBLIC HEALTH ORDER
PHASE 2 OF EAGLE COUNTY PLAN FOR SUSTAINING SOCIAL DISTANCE**

This Order:

- Supersedes the Standing Public Health Order for Phase I of the Eagle County Plan for Sustaining Social Distance dated April 27, 2020, as amended.
- Sets forth Phase 2 (“Blue Square” of the [Transition Trail Map¹](#)) of Eagle County’s protocol to further lift restrictions of previous health orders, provide updated limits on social distancing, gatherings, and businesses and facilities that may remain open, all in order to continue slowing the spread of the COVID-19 virus.

Pursuant to section 25-1-506 (2)(a)(I), Colorado Revised Statutes, this Order is effective as of May 25, 2020 within the entirety of Eagle County, including all towns within the County, until June 30, 2020.

This Order is adopted pursuant to the legal authority set forth in sections 25-1-506 and 25-1-508, Colorado Revised Statutes. Under these laws, the Director of Eagle County Public Health and Environment (“ECPHE”) has the duty to investigate and control the causes of epidemic or communicable diseases and conditions affecting public health and to establish, maintain, and enforce isolation and quarantine, and in pursuance thereof, and for this purpose only, to exercise physical control over property and over the persons of the people within the jurisdiction of the agency as

the agency may find necessary for the protection of the public health. All persons in Eagle County, including in all towns, must follow the requirements stated herein.

Where this Order or applicable guidance of Eagle County conflicts with an Order or guidance provided by the State of Colorado, Eagle County's Order or guidance applies.

I. BACKGROUND, PURPOSE, AND INTENT

Eagle County on May 11, 2020 requested exemptions from certain provisions of executive and public health orders of the Governor and the Colorado Department of Health and Environment ("CDPHE") on the basis that Eagle County has significantly reduced transmission of COVID-19 in the community and has adequate resources available such that Eagle County may begin relaxing public health restrictions. On May 22, 2020, the Executive Director of CDPHE granted Eagle County's request to allow the County to issue orders that supersede certain provisions of the state orders.

This Order implements Phase 2 of the Eagle County Plan for Sustaining Social Distance. The purpose of the Order is to further lift restrictions associated with COVID-19 in an incremental fashion that prevents resurgence while allowing our community to continue social and economic healing and recovery. Disease resurgence and management of disease spread is evaluated on a continuous basis and shared publicly through Eagle County's [Weekly Performance Indicator Dashboard](#)².

II. FIVE COMMITMENTS OF CONTAINMENT

Preventing a resurgence of COVID-19 in Eagle County requires all individuals and businesses to comply with the mandatory provisions in this Order. In addition, all persons in Eagle County are requested to assume additional personal responsibility and adopt the [Five Commitments of Containment](#)³ to keep transmission of the illness low.

These are:

1. I will maintain six feet of physical distance.
 - a. Physical distance is one of the most effective prevention measures.
 - b. I will keep this distance from any person who is not from my household.
2. I will wash my hands often.
 - a. Especially after visiting public settings, businesses, and before eating or touching my face.
3. I will cover my face in public.
 - a. I will wear a face covering whenever I may not be able to maintain my physical distance from others.
 - b. I will wear a face covering when entering an indoor public environment, like a grocery store or post office.
 - c. Face coverings are not a substitute for maintaining physical distance.
4. I will stay home when I am sick.
 - a. Isolating myself from others, including my household members, will help protect them and limit the spread.
5. I will get tested immediately if I have Symptoms.
 - a. Testing early after Symptoms develop can help prevent spreading COVID-19 to other people.

Should resurgence of COVID-19 appear likely based on a failure to adhere to this Order, stricter restrictions may be reinstated.

III. DEFINITIONS

In the sequence in which they appear in Section IV, below, and for purposes of this Order:

- A. "Symptoms" are the symptoms of COVID-19 infection, and can include headache, sore throat, fever, dry cough, inability to taste and smell, shortness of breath, ear aches, body aches, diarrhea, fatigue, vomiting

and abdominal pain.

- B. “Self-Isolate” is specific to a person with illness and means to stay at home, maintain distance (minimum of six feet) away from other household members, do not share a bedroom or bathroom, wear a mask to cover your mouth and nose when in common areas within the household, and do not leave the home unless seeking medical care.
- C. “Self-Quarantine” is specific to a person who does not have Symptoms but has been exposed to someone confirmed to have COVID-19 or who is experiencing Symptoms, and means to stay home, do not go to public places unless seeking medical care, and avoid contact with other people until the incubation period for COVID-19 is over, for 14 days.
- D. “Local Residents” are those persons whose primary and permanent home or residence is in Eagle County, or those persons who, for at least 30 days at a time, own, maintain, or live in a home or residence in Eagle County. In addition, persons living in areas of counties contiguous to Eagle County where Essential Services and Businesses are not readily available except in Eagle County are considered Local Residents for purposes of this Order.
- E. “[Essential Services and Businesses](#)”⁴ are those businesses deemed necessary for the community to continue to function and for which strictly limiting the number of attendees would present health, safety, and welfare concerns for the citizens of Eagle County.
- F. “Other Businesses” are those businesses that are not [Essential Services or Businesses](#)⁵ and not listed in Section IV(E).
- G. “Restaurants and Bars” include bars, taverns, taprooms, tasting rooms, brewpubs, distillery pubs, clubs, cigar bars, restaurants, and similar establishments.
- H. “Short Term Lodging” is any lodging or lodging space which is used by an occupant for less than 30 days. This includes, without limitation, developed campgrounds that are not dispersed individual campsites; bed

and breakfasts; lodges; retreats; hotels and motels; properties rented through Airbnb, VRBO, travel agencies, or similar companies or websites; units owned on a timeshare or fractional interest basis, condo-hotels, or similar resorts; or any other similar lodging types.

- I. “Recreational Facilities or Businesses using High-Touch Equipment or Equipment used by Multiple Guests” include without limitation outfitted or guided activities servicing guests for rafting, fishing, horseback riding, mountain biking, or similar activities; playgrounds; rock parks and climbing walls; pools, hot tubs, saunas, and spas; and similar areas for recreational activity with equipment that is frequently touched or is used by more than one guest.

IV. ORDER

A. Isolation and Quarantine Requirements for Symptomatic Persons and Exposures

1. Individuals experiencing Symptoms of COVID-19 must Self-Isolate as defined in Section III(B), above, for a minimum of ten (10) days from the start of Symptoms AND until they are fever free for a minimum of 72 hours (without the use of any fever-reducing medications) AND as long as Symptoms are significantly improving. This includes people that have tested positive, people awaiting their test results, and people who have Symptoms but have not been tested. Individuals experiencing Symptoms should contact a [local healthcare provider](#)⁶ for guidance and to schedule COVID-19 testing as quickly as possible.
2. Individuals with a close contact with confirmed COVID-19 disease, or a person who has Symptoms consistent with COVID-19 but who has not been tested, will Self-Quarantine, as defined in Section III(C), above, for 14 days at their place of residence. A close contact is a household member, intimate partner, someone that you may have shared a

drinking glass or eating utensil with, or someone who has been within six feet of a person that is sick for 10 minutes or longer. For healthcare workers and others responding to the COVID-19 pandemic, ECPHE will provide more specific guidance.

3. Employers do not need to and should not require negative test results or a medical release for anyone that has completed the Self-Isolation requirements in Section (IV)(A)(1), above, or the Self-Quarantine requirements in Section (IV)(A)(2), above, each as applicable.
4. In the event an employee has confirmed COVID-19 disease or has Symptoms but was not tested, employers should not recommend testing for any other employees as a condition of employment.
5. Employers should not otherwise require a negative test result as a condition of employment.

B. Limitations on Public and Private Gatherings for Individuals

1. No more than 50 persons may gather together for any purpose, unless another provision of this Order provides otherwise.
2. All persons gathering in groups of 50 or less must:
 - a. Adhere to social distancing requirements for individuals as set forth in Section (IV)(C), below.
 - b. Adhere to any additional applicable requirements if the gathering is organized by or held at a business or facility.

C. Social Distancing Requirements for Individuals

1. Individuals at greater risk of severe disease from COVID-19 (aged 65 years or older or have chronic lung disease, moderate to severe asthma, serious heart conditions, are immunocompromised, are pregnant, or are otherwise considered at high risk by a licensed healthcare provider) are safer at home. When necessary, extra precautions should be taken when leaving their homes:

- a. Maintain 6-8 feet of distance from others individuals.
 - b. Wear face coverings while in public.
 - c. Avoid settings with larger numbers of people and keep prolonged interaction with the general public to a minimum.
 - d. Limit gatherings and meet outside when possible.
 - e. Contact your healthcare provider immediately upon onset of Symptoms.
2. To reduce the risk of disease transmission, individuals must:
 - a. Maintain at least a six-foot distance from other individuals.
 - b. Where more than one group is allowed (outdoors only, unless the groups are at a business for which another provision of this Order provides an exception for multiple groups), keep a reasonable and safe distance from other groups of no less than 20 feet.
 - c. Avoid unnecessary physical contact (including hugs, handshakes, or fist bumps).
 - d. Wash hands with soap and water for at least twenty seconds as frequently as possible or use hand sanitizer.
 - e. These social distancing requirements do not apply to interactions among members of the same household.
 3. Non-medical, cloth face-coverings for the nose and mouth are strongly recommended for individuals to use in businesses or other facilities or in places where social distancing is required but cannot be adequately maintained.
 4. Individuals must comply with any additional social distancing requirements that businesses or facilities impose for gatherings they organize or for entry into their establishments.

D. Special Provisions for Non-Local Residents visiting Eagle County

1. Any person that is not a Local Resident that travels to or visits Eagle County (a “non-Local Resident”) must be free of any Symptoms consistent with COVID-19 before arrival.

2. If any Symptoms consistent with COVID-19 are present in the 10 days prior to arrival in Eagle County, the non-Local Resident must not travel to Eagle County.
3. All non-Local Residents will self-screen for Symptoms each morning during their travel within Eagle County.
4. All non-Local Residents that develop Symptoms consistent with COVID-19 during their travel within Eagle County will:
 - a. Adhere to Self-Isolation requirements in Section (IV)(A)(1) above, even if this prolongs their stay in Eagle County at the traveler's expense.
 - b. Contact a [local healthcare provider](#)⁷ for guidance and to schedule COVID-19 testing as quickly as possible.
5. All non-Local Residents that have been exposed to someone with Symptoms consistent with COVID-19 during their travel will:
 - a. Adhere to the Self-Quarantine requirements in Section (IV)(A)(2) above, even if this prolongs their stay in Eagle County and at the traveler's expense.
 - b. If Symptoms consistent with COVID-19 develop during the quarantine period, the traveler must follow the requirements outlined in Section (IV)(D)(4) above.

E. Services and Businesses that Must Remain Closed

1. The following businesses or facilities must remain closed while this Order is in place:
 - a. Saunas and steam rooms.
 - b. Any business or recreational facility that cannot meet the limitations in this Order as to the number of employees, customers, guests, and attendees; cannot meet the social distancing requirements as set forth in this Order; or cannot control the interactions between people to ensure they meet the requirements of this Order.

- c. Any businesses, except Essential Businesses and Services, that exclusively serve populations that are at higher risk from COVID-19 disease, which includes older adults (age 65 and older) and individuals with underlying medical conditions.

F. Open Businesses

1. Provisions Applicable to All Open Businesses

- a. All open businesses must report to ECPHE at (970) 235-0187 or diseaseprevention@eaglecounty.us any suspected or confirmed clusters of illnesses among employees where Symptoms are consistent with COVID-19, as defined in Section III(A), above.
- b. All open businesses must create a [Social Distancing Protocol](#)⁸ and adhere to the applicable social distancing requirements set forth in Sections IV(G) and (H), below.
- c. Businesses must allow employees to wear masks, including non-medical cloth face coverings and gloves if the employee desires to do so, even if the face coverings or gloves are not required by this or any other public health order.
- d. Employers are strongly encouraged to allow employees to work remotely where possible, and to adopt policies for paid sick leave if the employee is lab-confirmed with COVID-19.

2. Provisions Applicable to Essential Services and Businesses

- a. [Essential Services and Businesses](#)⁹ may exceed a total of 50 employees, customers, guests, or attendees as necessary for the health, safety, and welfare of, and to provide essential goods and services to, the community.
- b. The official and essential functions or training activities of health

care operators, utilities, law enforcement, fire prevention and response, emergency management and response, and any other critical governmental functions that are necessary to ensure public health, safety, and welfare are exempt from any provisions of this Order that would unreasonably restrict or preclude the necessary activity. Such activities should include social distancing to the extent practicable.

- c. Restaurants and Bars are subject to the following provisions:
- i. Restaurants and Bars may re-open for dine-in services. The number of persons that may gather in Restaurants and Bars is not limited to 50 persons, provided that the requirements in this Section IV(F) and for social distancing are met.
 - ii. Indoor seating is limited to no more than 50% of the number of tables the restaurant had on March 5, 2020. All seating must comply with the social distancing requirements in this Order.
 - iii. For indoor bars or bar areas in restaurants that allow patrons to stand, establishments must follow the additional [guidance of ECPHE](#)¹⁰.
 - iv. Outdoor seating or standing capacity is not limited except as is necessary to comply with the social distancing requirements in this Order.
 - v. Subject to the occupancy limits of this Order, Restaurants and Bars may continue delivery and takeout food and beverage service in accordance with state laws and orders, except that a Restaurant or Bar may not allow a patron to take alcohol with them when leaving after dine-in service, unless otherwise allowable under state or local law.
 - vi. Restaurants and Bars are subject to additional [guidance provided by ECPHE](#)¹¹, and all other laws, rules, and regulations

applicable to their businesses, including related to outdoor seating or serving alcohol.

3. Provisions Applicable to Other Businesses and Facilities that May Remain Open or Reopen.

a. General Provisions.

- i. Unless listed in Section IV(E) of this Order, Other Businesses and facilities in Eagle County may remain open or reopen, provided they meet all applicable requirements in this Order.
- ii. No more than 50 employees, customers, guests, and attendees together may gather at a facility, business, or at any event hosted by a facility or business, unless excepted below.
- iii. Exceptions:
 - A. Swimming pools with an appropriate disinfectant (e.g. chlorine or bromine) are not limited to 50 persons but rather to 50% of their otherwise allowable capacity or less as necessary to comply with the social distancing requirements in this Order.
 - B. For businesses not open to the public and that will not serve customers in person, the number of employees in a location is not limited to 50 employees where necessary to conduct business operations. Rather, a minimum six-foot distance must be maintained between employees and all other applicable social distancing requirements of this Order must be met.
 - C. For businesses with discreet and segregated areas of a building or facility, 50 persons may be in each discreet and segregated area provided they meet the minimum six foot distance between all persons.
 - D. For businesses or facilities that conduct operations outdoors, multiple groups of 50 persons are allowed, provided they meet the six foot distance between each

- person and each group is distanced by no less than 20 feet.
- E. Short Term Lodging is not limited to 50 persons, but is subject to additional restrictions, below.
- b. Short Term Lodging operators are subject to the following restrictions:
 - i. Short Term Lodging may open at 50% occupancy capacity as further defined below. Prior to opening, lodging operators must develop a plan¹² that complies with this Order and that limits Short Term Lodging occupancy for any given day.
 - ii. For all operators of multi-unit establishments such as hotels, motels, private residence or resort clubs, condo-tels, ownership associations, and other similar Short Term Lodging establishments:
 - A. Operators must restrict occupancy to no more than 50% of the total number of units in the establishment.
 - B. For the avoidance of doubt, this provision applies to any business, operator, association, club, or resort that organizes, rents, allocates, or otherwise administers the occupancy of such units as of the date of this order, regardless of how ownership of the unit is held, whether or not the unit is rented or is subject to membership, association, or other fees, or there is otherwise an exchange of money for the services of the operator.
 - iii. For all operators that administer single Short Term Lodging units:
 - A. Occupancy must be restricted to one person per bedroom, plus one additional person in the unit, or to the occupancy allowed by the local jurisdiction, if any, whichever is less.
 - iv. In addition to all other requirements applicable to Short Term Lodging, operators of facilities that have shared bathrooms or

food preparation facilities, including but not limited to hostels, mountain huts, or similar facilities, must follow the applicable [guidance of ECPHE](#)¹³.

- v. Short Term Lodging operators must inform guests about the restrictions in this Order, including by:
 - A. Providing all guests with information about the [Five Commitments of Containment](#)¹⁴.
 - B. Explaining the Special Provisions for Visitors in Section IV(D), above.
- vi. Exceptions:
 - A. Short Term Lodging that does not meet the requirements in this Section IV(F)(3)(b) must remain closed to guests.
 - B. Units where a deed conveying ownership to an owner provides specifically identifiable dates of ownership (examples include: “June 21-27”; “Week 20”, or “the third week of January”) and the owner occupies the unit during the dates of their deeded ownership need not be counted toward the 50% occupancy limit in Section IV(F)(3)(b)(ii).
 - C. The Director of ECPHE, or his designee, may provide a special exception to the restrictions on Short Term Lodging where the Director determines there is good cause to do so.

G. Social Distancing Protocol Required for All Open Businesses and Services

1. Prior to opening, all employers or facility operators must prepare a “Social Distancing Protocol” for each of their open facilities or operational locations in Eagle County. The [Social Distancing Protocol](#)¹⁵

must address the social distancing requirements in Section IV(H), below.

2. The Social Distancing Protocol must be posted at or near the entrance of the relevant business or facility, and shall be easily viewable by employees, customers, guests, and attendees. A copy of the Social Distancing Protocol must also be provided to each employee performing work at the facility. Businesses are not required to provide a copy of the Social Distancing Protocol to Eagle County unless specifically requested.
3. All employers must implement the Social Distancing Protocol and provide it and evidence of its implementation upon demand to any authority enforcing this Order.

H. Social Distancing Requirements for All Open Businesses and Services

1. All open businesses must employ a minimum of the social distancing requirements below, unless this Order or applicable guidance referenced in this Order provides otherwise.
 - a. A business may impose additional, reasonable social distancing measures that apply to persons who enter its premises or attend a gathering it organizes. A business may deny entry to, or otherwise refuse to serve, individuals who refuse to comply with such additional requirements.
2. Required Social Distancing Measures:
 - a. Employers are encouraged to make safer accommodations, including tele-work, where possible for employees at greater risk of severe disease from COVID-19 (aged 65 years or older or have chronic lung disease, moderate to severe asthma, serious heart conditions, are immunocompromised, are pregnant, or are otherwise considered at high risk by a licensed healthcare provider).
 - b. Employees must be screened for COVID-19 Symptoms each day

and excluded if symptomatic as described in the self-isolation requirements in Section IV(A)(1).

- c. Social distancing measures must be implemented to ensure that employees and individuals can easily maintain a minimum six-foot distance from each other. Achieving adequate social distancing may require limiting the number of people that can enter or participate in a business at any one time.
 - i. Exception: Persons may be within six feet for momentary circumstances to accept payment, deliver goods, walk past, or perform otherwise necessary tasks.
 - ii. Exception: Persons may be within six feet where the nature of the business makes closer proximity to a person necessary, such as in the provision of personal services.
 - iii. Exception: Household members do not need to maintain six feet of distance amongst themselves, but still must maintain the required distance from others.
- d. Employees of Essential Businesses or Services allowed to open under this Order must comply with the Colorado Executive Order 20-39, as amended and applicable, which requires these employees who work in close proximity to other employees or with the public (within the minimum six-foot distance from each other, beyond the momentary circumstances described in Section IV(H)(2)(c), above), must wear a non-medical cloth face covering. In addition, all employees who come into contact with customers or goods should wear gloves, if gloves are provided by their employer.
- e. Vehicles other than those used for public transit or emergency response to transport multiple employees of a business or its guests, or attendees are a higher-risk environment. To reduce the risks of COVID-19 exposure, the following requirements apply:
 - i. Employees, guests, and attendees must be screened for COVID-19 Symptoms each day and be excluded if symptomatic,

- as described in the self-isolation requirements in Section IV(A)(1).
- ii. Employees, guests, and attendees must use hand sanitizer upon entering the vehicle and must cover their nose and mouth with a non-medical, cloth face-covering when in vehicles with more than one person.
 - iii. The number of passengers must be limited to 50% of a vehicle's occupancy to increase the distance between passengers to the largest extent possible.
 - iv. Windows must remain open and/or ventilation must be increased.
 - v. Vehicles must have high-touch surfaces disinfected daily.
 - f. Where lines may form at a facility, six-foot increments at a minimum must be marked on the ground or floor establishing where individuals should stand to maintain adequate social distancing.
 - g. [Signs at the entrance of a facility must be posted](#)¹⁶ informing all employees and customers that they should: avoid entering the facility if they have a cough or fever; maintain a minimum six-foot distance from one another; sneeze and cough into one's elbow; not shake hands or engage in any unnecessary physical contact.
 - h. Hand sanitizer, soap and water, or effective disinfectant should be made available at or near the entrance of the facility and in other appropriate areas for use by attendees or guests, the public, and employees, and in locations where there is high-frequency employee interaction with members of the public (e.g. cashiers);
 - i. Contactless payment systems should be provided, or, if not feasible to do so, all payment portals, pens, and styluses must be disinfected after each use; and
 - j. Other high-touch surfaces should be regularly disinfected and

environmental cleaning guidelines from the US Centers for Disease Control and Prevention (CDC) must be followed (e.g., clean and disinfect high touch surfaces daily or more frequently).

3. Additional Provisions for Certain Open Businesses or Facilities
 - a. Businesses subject to regulation and licensing by the State of Colorado must also comply with all applicable rules, regulations, and guidance of the appropriate licensing department.
 - b. Additional guidance for businesses may be found at the State of Colorado's [Safer at Home](#)¹⁷ website. Where this Order or the applicable guidance of Eagle County conflicts with an Order or guidance provided by the State of Colorado, Eagle County's Order or guidance applies.
 - c. The following businesses or services are subject to [additional ECPHE Industry Specific Guidance](#)¹⁸, which may provide clarification on certain aspects of social distancing or other requirements in this order:

V. **GENERAL INFORMATION FOR ALL PERSONS AFFECTED BY THIS ORDER**

ECPHE is tasked with protecting the health and welfare of the citizens of Eagle County, Colorado by investigating and controlling the causes of epidemic and communicable disease. This Order is necessary to control any potential transmission of disease to others. See section 25-1-508, Colorado Revised Statutes. Immediate issuance of this Order is necessary for the preservation of public health, safety, or welfare.

Any person aggrieved and affected by this Order has the right to request judicial review by filing an action with the Eagle County District Court within 90 days of the date of this Order, pursuant to section 25-1-515, Colorado Revised Statutes. However, you must continue to obey the terms of this Order while your request for review is pending.

FAILURE TO COMPLY WITH THIS ORDER IS SUBJECT TO THE PENALTIES CONTAINED IN SECTIONS 25-1-516 AND 18-1.3-501, COLORADO REVISED STATUTES, INCLUDING A FINE OF UP TO FIVE THOUSAND (5,000) DOLLARS AND IMPRISONMENT IN THE COUNTY JAIL FOR UP TO EIGHTEEN MONTHS. EAGLE COUNTY PUBLIC HEALTH AND ENVIRONMENT ALSO RESERVES THE RIGHT TO SEEK ANY OTHER REMEDIES AVAILABLE BY LAW.
